1. Cookies

We do not collect any personal information from you. We do, however, use third-party services such as Google Analytics, which may receive your publicly available personal information. We are not responsible for any information that is publicly available on the Ethereum blockchain as a result of your actions through the front-end interface.

3. Third party wallet

In order to use our services, you must use a third-party wallet that allows you to transact on the public blockchain. Your interaction with any third party wallet provider is governed by the applicable terms of service and privacy policy of that third party.

4. Data protection

We care about the security of your information and use physical, administrative and technical safeguards to maintain the integrity and security of the information collected through our services. However, no security system is impenetrable, and we cannot guarantee the security of our systems. If any information in our custody and control is compromised as a result of a security breach, we will take steps to investigate and remedy the situation and notify those individuals whose information may have been compromised, in accordance with applicable laws and regulations.
